How does it work?

1st stage

- Analyzing subject documents and correspondence/ analyzing the claim;
- Initiating the arbitration/acceptance of initiation;
- Arbitrator nomination;
- Analyzing the relevant rules of English Law;
- Conclusion of legal position;
- Collections of evidences;
- Preparation and serving the claim/defense submissions.

20 h

2nd stage

- Analyzing the defense/ reply submissions (2nd tier of documents exchange);
- Preparation of reply to the counterparty's submissions.

10 h

3rd stage

- Analyzing of further submissions;
- Replies to further submissions;
- Receiving the Award.

3-5 h

+ success fee 10% (of awarded/defended amount of claim).
Arbitration costs and expenses (courier, translations, notary) are paid additionally.

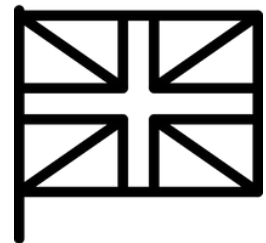

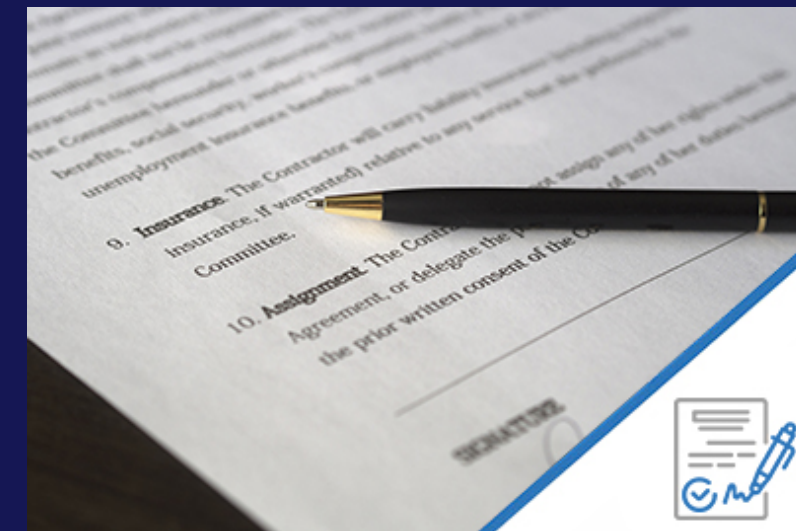
