The set of docs which is usually required

1. To act on behalf of your company:

- 1 Apostilled POA.
- 2 Legal Service agreement.
- 3 Apostilled Certificate of incorporation, Extract from the Register, Articles of association.

2. To prove the debt before your company:

- 1 Your company's Terms and Conditions.
- 2 Copies of all: agreements; bunker delivery receipts; sales and other confirmations; invoices; letters and e-mail correspondence.
